Asper the Representation of People Act, 1951

134. Breaches of official duty in connection with election—

(1) If any person to whom this section applies is without reasonable cause guilty of any act or omission in breach of his official duty, he shall be punishable with fine which may extend to five hundred rupees. (1A) An offence punishable under sub-section (1) shall be **cognizable***.

*means an offence for which a police officer may arrest without warrant.
