To inspect the polling station during the poll hours on Poll Day and starting poll report sent to the respective SDM/RO at 08-00 am on telephone and 2nd report 10-00 am. 3rd report at 12-00 noon, 4th Report at 02:00 Pm and last poll report to the respective SDM/RO after 04-00 pm and update date on PAMS app and provide assistance to Presiding Officer, where necessary and also maintain co-ordination with undersigned.
4. To assist the Presiding Officer for counting.
5. To assist the Returning Officer after the poll in collection of election material and deposit the same in safe custody in the strong room.
6. To perform any other election duty as assigned from time to time.
