mment and Governo of Student Legal Literacy Clubs in all the Government and Government Aided Colleges in the State of Punjab.

Under the directions of NALSA, the Hon'ble Executive Chairman, Punjab Legal Services Authority has approved the Scheme for establishing of Legal Literacy Clubs in all the Government and Government Aided Colleges of the State of Punjab. The guidelines for setting up of such clubs are as under:

- The Clubs may be set up in association with National Services Scheme. Such Clubs may be headed by the N.S.S Programme officers and by a Teacher nominated by the Principal of the College. The Clubs members shall report their activities to the Programme officer/Teacher incharge.
- ii. A College may have more than one club with distinct name for identity, but each club shall not consist of more than 25 Students.
- iii. Each Club shall undertake following activities on weekly or monthly bases for spreading Legal Literacy:
 - a) Painting
 - b) Slogan Making
 - c) Poster Making
 - New Year Greeting Card Making d)
 - Street Plays e)
 - Debate and Declamation f)
 - Paper Reading g)
 - Legal Awareness Camps/ Seminars h)
 - Any other activity as recommended by District Legal Services i) Authority/Sub-Divisional Legal Services Committee/Incharge of the club.

The major focus areas for the above said activities are as under-:

- Rights of Women in property
- Cruelty against Women/Domestic Violence a)
- b)

- c) Harassment of Women at Work Places.
- d) Female Foeticide
- e) Drug Addiction
- f) Corruption
- g) Fundamental Rights/Duties
- h) Human Rights
- i) Consumer Rights
- j) Legal Literacy
- k) Bounded Labour
- Menace of Dowry
- m) Right to Information
- n) Laws on Marriage and Divorce
- o) Rights of Senior Citizens
- p) Labour Rights
- q) Right of Children for free and Compulsory Education
- r) Lok Adalats and Legal Aid
- S) Any other topic/Social Problems considered by the District Legal Services Authority/Sub-Divisional Legal Services Committee to be included for spreading awareness among masses.
- iv. The Club members shall be briefed by the District Legal Services Authority (DLSA)/Taluk Legal Services Committee (TLSC) about the salient features of important laws. They shall also be briefed about the modus operandi of legal services by the Legal Services Authorities/Committees, pre-litigation settlements of disputes, Lok Adalats and ADR.
 - v. The Club Members shall be encouraged to identify persons in their neighborhood who deserve legal aid and who are in need of protecting their rights.
 - vi. The Club members, with the recommendation of the NSS Programme
 Officers/Teacher In-charge, may bring the persons in need of legal

services to the nearest District Legal Services Authority / Taluk Legal Services Committee.

- vii. The DLSA/TLSC shall keep a register of the Clubs within their jurisdiction and a record of their activities, invite annual reports from the Clubs.
- viii. DLSA / TLSC shall evaluate the work done by the Clubs and may institute cash award not exceeding Rs. 2000/- for the best Legal Literacy Club in the taluk, every year. In the same manner, the DLSA may select one best Club from amongst the Colleges within that District for state level competition Certificate/Mementoes also may be given to the best Club.
 - ix. Each Club shall submit a Monthly Report alongwith the Photographs, Press releases of their activities to the Chairman of the District Legal Services Authority/Taluk Legal Services Committee concerned. The report should be self explanatory and should highlight the events undertaken by the club and the problems being faced by the common man within the area of their activity.
 - x. Each club should maintain a register of activities and record the work done by the Club Members.

The District Legal Services Authority/Sub-Divisional Legal Services Committees be associated for holding seminars/workshops/Legal Literacy Camps and competitions etc.
