#### Action points

- 1) Children below 5 years to be enrolled- camps to be organized in Institutional delivery Hospitals, nursing homes, vaccination centers and Aganwadis.
- Aadhaar Camps to be organized in all Government schools and private recognized schools.
- 3) Mandatory Biometric Update of children who have attained the age of 5 years and 15 years to be performed.
- 4) Aadhaar camps be organized in colleges, Technical educational institutions for updation of student's Aadhaar.
- 5) Aadhaar Camps to be organized in institutions for differently abled persons, orphanages and old age homes.
- Awareness and mobilization of residents to Aadhaar camps to be promoted.
- 7) Document updates of residents, who have not updated Aadhaar in the last 10 years need to revalidate Aadhaar by uploading POI/POA documents.
- Regular inspections of Aadhaar centers by district functionaries.
- Verification of pending adult enrolments to be completed within timelines regularly.
- 10) Verification of Aadhaar and Authentication to be done by district authorities while using Aadhaar for service delivery
- 11)Information on Aadhaar be widely disseminated through Print and social media as well and press notes be published in leading dailies
