Dear Ma'am/Sir,

Kindly refer to this Department's D.O. letter No. 4-3/2025-ATL dated 16th October, 2025, regarding the submission of ideas/prototypes on the *Viksit Bharat Buildathon (VBB)* portal. States and UTs were requested to ensure that every registered school team submits its idea or prototype (in video format under two minutes) through the official portal <https://vbb.mic.gov.in>.

2. Based on requests received from several States/UTs for additional time to facilitate broader participation, the submission deadline had been extended till 8th November, 2025. It is reiterated that **no further extension will be granted**.

3. As the final date is approaching fast, it is requested that your Department may take immediate steps to ensure **submission of ideas/prototypes** from **all registered teams** in your State/UT. The following actions are suggested for effective implementation:

- Disseminate the extended timeline widely through the State/ UT/ District education offices, SCERTs, DIETs, and official communication channels to reach all schools.
- Direct district and block-level officers to monitor submission progress daily and provide handholding support to schools wherever required.
- Motivate teachers to mentor student teams and make use of the curated **learning resources and guidance materials** available on the VBB portal to enhance the quality of submissions.
- Urge schools to complete **early submissions** to avoid last-day congestion and ensure smooth processing on the portal.

4. The *Viksit Bharat Buildathon 2025* is a national initiative to foster innovation, creativity, and problem-solving among students in alignment with the vision of *Viksit Bharat @2047*. I seek your **personal attention and leadership** in ensuring that all schools under your jurisdiction actively participate and submit their entries by the stipulated date.
