Speaking Order

Smt. Gagandeep Kaur, English Mistress, Government High School Kamalpur, Block Sunam 2, District Sangrur and others, (Whose list is enclosed with this order) had filed civil Writ Petition No. 24893 of 2025 in the Hon'ble Punjab and Haryana High Court with the prayer for issuance of a writ in the nature of mandamus directing the respondents to consider the claim of the petitioners for extending them the benefit of judgment of Hon'ble High court in case of Saurabh Sharma & others vs State of Punjab & others, Cwp 15896 of 2023 decided on 13.09.2024 (Annexure P-5) and followed in many other similar matter including "Cwp No 22995 of 2024 Imran Hussain and others vs State of Punjab & others (Annexure-6) decided on 14.10.2024 which principal judgment has been further affirmed by the Hon'ble Division Bench vide judgment order dated 10.12.2024 (Annexure P-10) and further up held by the Hon'ble Supreme court vide order dated 20.01.2025 passed in SLP (C) No. 1158 of 2025 (Annexure P-11), with all consequential benefits, as per their entitlement from the due date till the date of actual benefits, and release the same along with interest on its delayed payment at the rate of 12% per annum from the due date of their entitlement till the date of actual payment in their favour. The Hon'ble Punjab & Haryana High Court disposed of the petition vide order dated 26.08.2025. The operative portion of the order is reproduced as below:-

"At this state, it would be appropriate to direct the respondent No. 1 to decide the legal notice-cum representation dated 02.08.2025 (Annexure P-9) in view of the law laid down by this court in CWP-15896, titled as "Saurabh Sharma and others Vs state of Punjab and Anr." Dated 13.09.2024 (Annexure P-12) and in LPA-2977 of 2024 (O&M), title as "State of Punjab and Anr. Vs. Dr. Saurabh Sharma and others" (Annexure P-13) within a period of three months of date of receipt of certified copy of this order.

Needless to observe that the respondent No. 1 shall pass a speaking and well reasoned order in the light of the above referred judgments as well as relevant rules/instructions and in case, it is found that the petitioners are entitled to relief claimed in the representation, consequently, all benefits may also be released to the petitioners within a period of one month, thereafter, along with interest."

In Compliance with the above said direction of the Hon'ble Court, I have carefully gone through the order dated 26.08.2025 and legal notice cum representation dated 02.08.2025 (P-9) vide which they have claimed the pay scale

applicable upon them, according to the applicable rules and refix the pay accordingly.

I have examined the claim raised by the petitioners and also considered the order of Hon'ble Court in CWP No. 15896 of 2023 tiled as Saurabh Sharma and others versus State of Punjab and another in which it was held that all candidate appointed under the same recruitment process are entitled to equal pay as per the 2016 Rules regardless of actual appointment date in terms of which the present Petition has been disposed of . The relevant portion of the judgment in CWP No. 15896 Of 2023 followed in Saurabh Sharma 's case is as under:-

"At this stage , learned counsel for the petitioners submit that though the petitioners have claimed interest but keeping in view the fact that they are only interested in the pay scale as entitled to them under 2016 Rules, they are not pressing their claim for the grant of interest..."

The Service of petitioners are governed by the " The Punjab Educational (Teaching Cadre) Group C Service Rules, 2018 and The Punjab Educational (Teaching Cadre) Border Area Group C Service Rules 2018." Rule 5 of the said rules provide that, " The members of the Service Shall be entitled to such scales of pay as may be authorized by the Department of Finance from time to time .

Accordingly, the approval is hereby accorded to fix the pay of the petitioners as per the above mentioned 2018 rules. Further According to the Punjab Civil Service (Revised Pay) Rules, 2021, notified by the State of Punjab Vide Notification No. 09/01/2021-5FP1/671 dated 05.07.2021, these pay scales are not applicable to employees recruited on or after 17.07.2020. The relevant part of the said rules is reproduced below:-

" 2 (2) They shall not apply to the (b) Government Employee recruited in the service of State of Punjab or the Punjab Vidhan Sabha on or after 17.07.2020, on whom pay scales on the pattern of the Government of India are applicable."

- The salary under the Departmental Rules shall be taken as the basis.
- The corresponding basic pay shall be fixed at the same stage, or if not available, at the next higher stage in the 7th CPC pay level notified for the post.

(DA rates shall be applied strictly in accordance with Annexure 'A' as clarified in the earlier instructions.)

ii) Employees covered under instructions dated 15.01.2015

- During the probation period, if the minimum pay in the pay band under Departmental Rules is lower than Cell-1 of the 7th CPC pay level, pay shall be fixed at Cell-1, being more beneficial.
- If such pay is lower than applicable DC rates, DC rates shall apply.
- On successful completion of probation, pay shall be fixed strictly as per Para A or Para B(i), as applicable."


Accordingly, in compliance of the orders dated 26.08.2025 passed by the Hon'ble High Court & in light of the above said directions dated 05.01.2026 issued by the competent authority, i.e, The Department of Finance, Punjab, the pay of the Petitioners be refixed strictly as per instructions contained in para 5 of the said instruction dated 05.01.2026.
