1. Ensure that Special Camps are organised at all polling booths under the respective Assembly Constituency on Sunday, 16.08.2026, from 10:00 AM to 1:00 PM, with all concerned BLOs remaining present throughout the camp.
2. Ensure that BLOs assist electors in checking and verifying their names and particulars in the Draft Electoral Roll and facilitate eligible left-out electors in submitting Forms 6, 6A and 8, wherever applicable, along with the prescribed declarations and supporting documents.
3. Ensure that sufficient copies of Forms 6 and 8 are available at all polling booths and that the duly filled forms received during the camp are properly collected and deposited with the concerned ERO for further necessary action.
4. Ensure that BLAs of all recognised political parties are duly informed about the Special Camp and that adequate publicity is undertaken through social media, munadi, local publicity and other available means to ensure maximum participation of eligible electors.
5. The concerned EROs shall personally monitor the conduct of the Special Camps, ensure adequate arrangements at all polling booths and strict compliance with the above directions. Any issue requiring intervention shall be brought to the notice of the undersigned promptly.

Subject: Conduct of Special Camp on all booths for publicising Draft Electoral Roll: SIR-2026 on Sunday, 16th August 2026.

As you are aware, the Draft Electoral Roll is to be published on 13.08.2026, and the second phase of SIR 2026 will commence from 13.08.2026 and continue till 12.09.2026. In order to facilitate voters in checking and verifying the published Draft Electoral Roll SIR-2026, Special Camps shall be organized at all polling booths on **16th August 2026** from **10:00 AM to 1:00 PM**. All BLOs shall remain present at the camp from 10:00 AM to 1:00 PM.

Instructions for conduct of the camps are as under:

1. Emphasis shall be laid on the following:
 - I. Assisting voters in checking and verifying their names in the Draft Roll.
 - II. Facilitating left out eligible voters to submit Form 6, Form 6A, and Form 8, wherever applicable, along with the required declaration/supporting documents. It is required to be ensured that BLO's have sufficient number of form 6 and form 8 in hard copies and that the filled forms are deposited in the office of the electoral registration officers.
 - III. Informing BLAs through Political Parties and BLO's about the Special Camp and encouraging maximum public participation.
2. **Polling Booths:** Heads of Departments be directed to keep the buildings of the polling booths open for the day and adequate arrangements be made for the camps.
3. **Public Awareness:** Adequate publicity through press notes, social media, munadi, and other mediums must be ensured for maximum participation.
4. **Political Parties:** All recognized political parties are required to be duly informed so that BLAs can mobilize voters for maximum participation.
5. 2-3 Good quality pictures per district may be sent to this office upon the completion of the camp.

You are requested to personally monitor the conduct of these camps and ensure full compliance.
