Speaking Order

Sh. Ravinder Singh s/o Sh. Tarlok Singh, Government High School Dhanauri, Block Morinda, District Rupnagar, R/o House No. 86, Ward No. 12 Kurali, Teh- Kharar, District SAS Nagar and 52 others (whose list is attached) filed Civil Writ Petition No. 35078 of 2025 for directing the respondents to grant the full pay in the regular pay scale of Rs. 10300-34800+5000 Grade Pay w.e.f. the date of initial appointment alongwith arrears, interests & all other consequential benefits. The Hon'ble Punjab & Haryana High Court disposed of the petition vide order dated 27.11.2025. The operative portion of the order dated 27.11.2025 is reproduced below:-

"In view of the above and without commenting upon the merits of the case, this petition is hereby disposed of with a direction to respondent No. 2 to consider and decide the legal notice dated 28.10.2024 (Annexure P-7), served by the petitioners within a period of 02 months from the date of receipt of certified copy of this order in accordance with law.

In case the petitioners are not held entitled for grant of benefit as claimed in the legal notice, a speaking order shall be passed and a copy of the same be supplied to the petitioners.

In case the petitioners are held entitled for grant of relief as claimed in the legal notice, in that case, the necessary relief be given to the petitioners in accordance with law within a period of one month thereafter."

In compliance with abovesaid directions of the Hon'ble Court, I have carefully gone through the order dated 27.11.2025, order dated 26.10.2018 (P-5) passed by the Hon'ble Court in CWP No. 6391 of 2016 titled as Dr. Vishavdeep Singh & others Vs. State of Punjab & others, legal notice dated 28.10.2024 (P-7) asserted to be served upon by the petitioners and official record pertaining to this matter, produced before me. After perusal of the record it has come to notice that the judgment of Rajasthan High Court in Gopal Kumawat Versus The State of Rajasthan & others (arising out of CWP No. 2963 of 2007, decided on 29.07.2018), which was relied upon by the Hon'ble High Court while deciding CWP No. 8922 of 2017 titled as Gurwinder Singh & others Versus State of Punjab and CWP No. 6391 of 2016 titled as Dr. Vishavdeep Singh and others versus State of Punjab and others, is the subject matter of SLP No. 25565 of 2015 titled as State of Rajasthan Vs Sh. Gopal Kumawat and others which is still pending. The Hon'ble Apex Court on 01.06.2020 was pleased to pass the following interim order in SLP No. (Dairy No.) 4762 of 2020

"In the meanwhile , the contempt proceedings, if any shall not proceed with"

Further it is pertinent to mention that in a similar matter SLP (civil) Dairy No. 27201 of 2023 arising out of order dated 20.09.2023 in CWP No. 31056 of 2018 has been filed by the department in which on 22.09.2023 the Hon'ble Supreme Court was pleased to pass the following order:-

"In the meanwhile, the contempt proceedings, if any, initiated against the petitioners shall remain stayed"

Hence the matter is still under adjudication before the Hon'ble Supreme Court and has not attained finally as yet.

In view of the facts, circumstances and legal position discussed above, I am of the considered opinion that claim raised by the petitioners through legal notice dated 28.10.2024 is premature at this stage as the matter has not attained finality.

In the given circumstances claim of the petitioners for grant of pay scale of Rs 10300-34800+5000 grade pay w.e.f. the date of initial appointment i.e. during probation period is, hereby rejected.

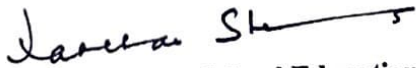
